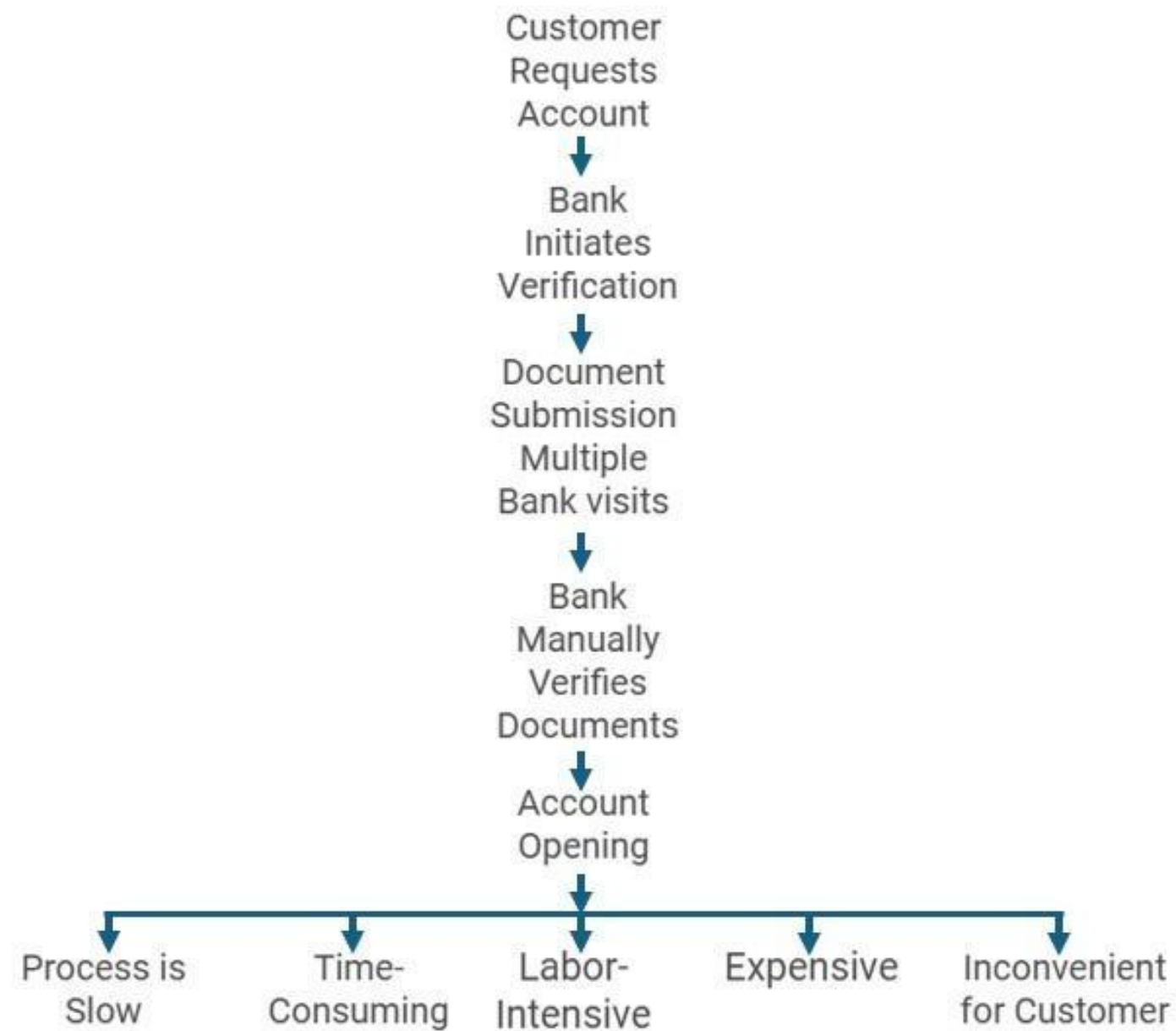
# *vDigiDocr* eKYC Solution Flowchart



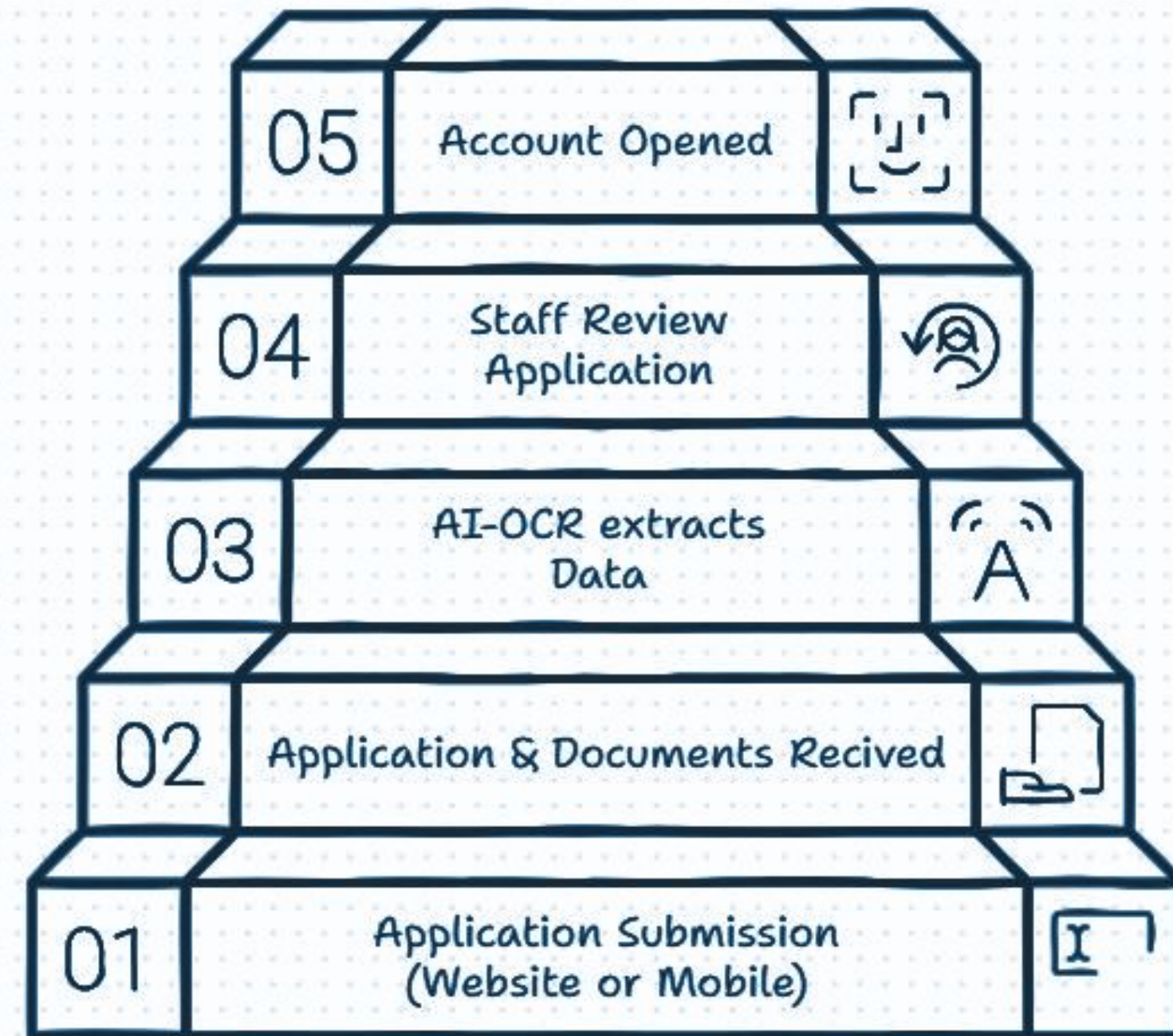

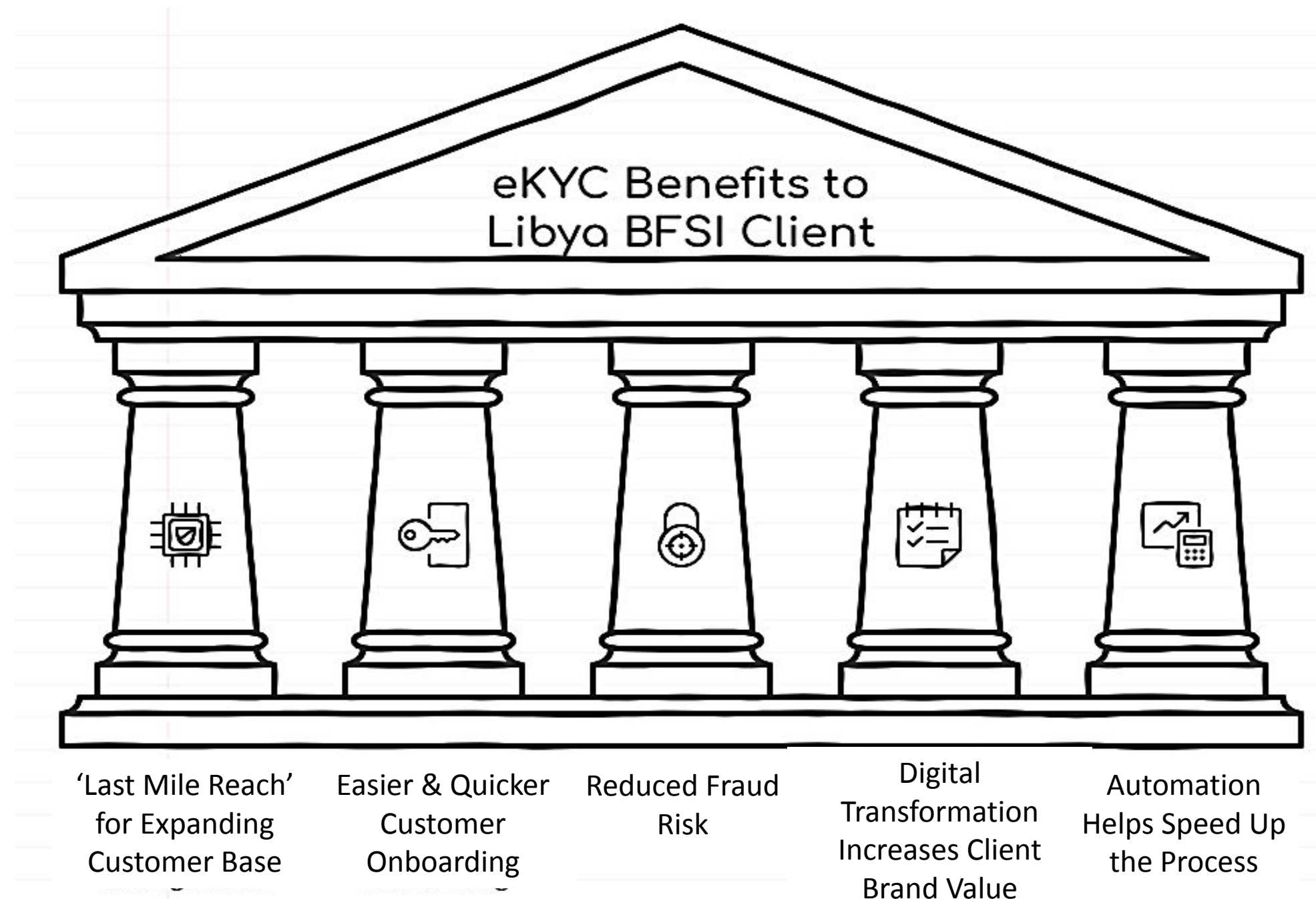
